2. Budget Update: Juan Vázquez	Information	 a. SCC is starting the year with a tentative budget that has gone from \$7 million last year to \$6.3 million this year. If the next "trigger" of cuts occurs, approximately \$3.5 million district-wide will be cut from this year's budget. SCC's share will be around \$900,000. b. August 4th is the deadline for SAC/SCC to submit their cuts to the district. These numbers will be reviewed by fiscal and used to create the adopted budget, which will be presented to the Board in August. The state deadline for the adopted budget is September 15. c. A master (prioritized) list of cuts will be collated from the submissions by the college's major units (Academic Affairs, Student Services, OEC, and Administrative Services). d. The District Enrollment Management Committee (DEMC) is scheduled to meet on August 11. e. Steve presented the SCC General Fund Budget Report. He explained the report had to be updated several times due to the addition of summer classes and other related costs. It is possible 	

		that next year's SCC budget (after cuts) will start at a number below the current cost of part-time instruction. SCC may need to commit money out of this account to meet the required reductions.
