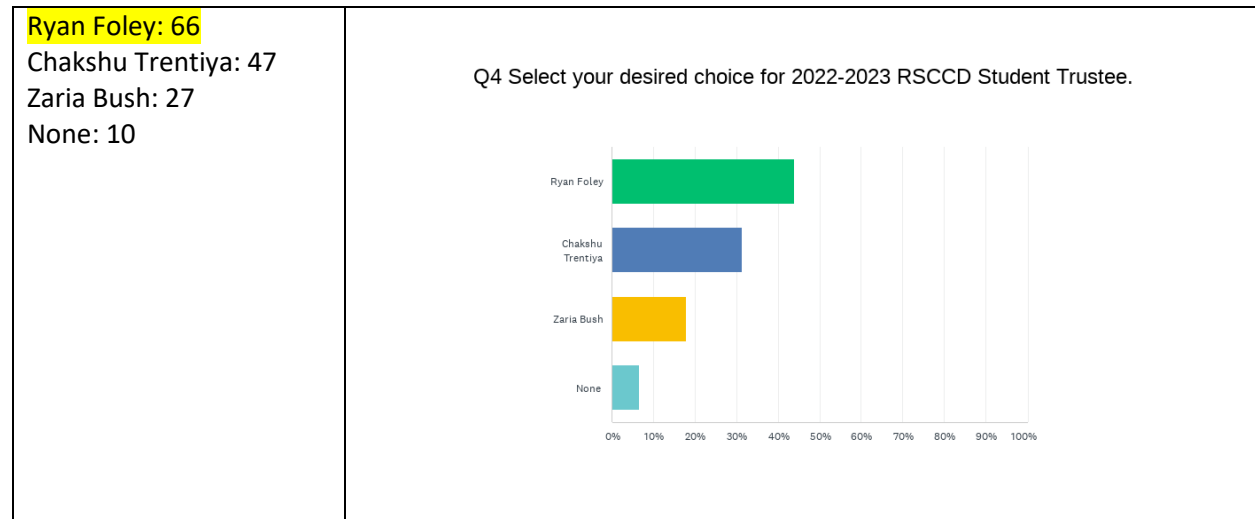
Total # of Votes: 191
